 From the time a case is called in until a report is submitted to the agency



WHAT HAVE WE DONE TO TRY TO BECOME MORE EFFICIENT?

- × NIJ grants: >3 Million over eight years
- × Interns: 1-3 Interns every summer
- Automation: First small lab in the in the US to use robotics
- × Volunteers: clerical mainly
- × Process Mapping: 2004, re-organized lab
- × Increasing Staff

The lab was not complaining... we just want a better business practice...



WHAT WAS IN THE BACKLOG?

August 15th, 2008: the FBU was 1,770 cases backlogged

Conducted review of all 1,770 cases and found:

- 411 Cases were not proceeding to a judicial finding
- 115 Cases no evidence submitted

What about the other 1,209 Backlogged Cases?



CULLING CASES

1,209 CASES

618 (51%) NEED MORE INFORMATION

- Need to submit victim, elimination, suspect standards
- Where evidence is found (inside or outside)
- How is the evidence related to crime
- Need to know what "Swabs for DNA" means
- Need to know what evidence is investigative (too many items submitted)
- Evidence not submitted

591 (28%) ACTIVE, READY TO BE ASSIGNED •But which ones are truly probative?


The analysts are spending an inordinate amount of time trying to figure out what samples to test.




When were the 1,209 backlogged cases submitted?






TOTAL NUMBER OF CASES CALLED-IN (AS OF 08-15-08)



SHOULD PROPERTY CRIMES BE WORKED? CASES WORKED V CODIS HITS ANSWER: YES



WHY DID THE BACKLOG BECOME SO LARGE?

- 1. ASAP CASES: Too many expedited cases; Never called in, going to court
- 2. CSI AFFECT: Regardless of the evidence or type of case, juries expect DNA × BURGLARY SUBMISSIONS:
 - Swabs of: door knobs, sliding screen doors, closet doors, deadbolts, dresser drawers, end tables, jewelry boxes, cables to TV's/computers, suspect, "may have touched", items from garbage, medicine cabinets,
 - Cars: steering wheels, dashboards, buttons to radio, latch to glove box, consoles, inside driver and passenger-front/back seats, 25-30 sets of swabs
- 3., GTA
- * Entire interior of car and anything found on the exterior, including surrounding area

4., ROBBERIES

× Swabs of: purse straps, urine in the bathtub, rumbottles, victim's arms, Countertops, cash drawer, candy wrappers, store displays, masks, shoes, duct tape, zip ties, radar detector, hats, lighters, victim cell phone, safe, wallet, pockets, boxer shorts, "liquid", edge trimmer, weed whacker, bicycles, Swabs of: door knobs, sliding screen doors, closet doors, deadbolts, dresser drawers, end tables, jewelry boxes, cables to TV's/computers, suspect, "may have touched", items from garbage, medicine cabinets,

•LE Agency:


*There were grumblings originally but after the training, we got it *Now at the crime scene we are already evaluating which samples will be going to the lab
