

Weight and Height Specifics:

- Dropdown menus include Estimated, Measured, & Cannot be Estimated options; one *must* be chosen
- Numerical values should be entered when possible; however:
 - <u>Do Not Use</u>:
 - Zeros (leave blank, if cannot be estimated)
 - Weights of decomposed remains, especially skeletons (leave blank)



Body Condition & Time Since Death:


- In addition to Recognizable Face, there are numerous options to be used when the individual is unrecognizable
- If year of death is confident, enter that year in both boxes; if not, use a range
- PMI dropdown includes minutes, hours, days, weeks, months, years; using an associated numerical value is optional
